



Q1 Regarding your time spent in the City of Spokane Valley, check all that apply:





Q2 How would you describe the current overall pavement condition of Spokane Valley's streets?









Q5 Given budget constraints, which street type should be prioritized for preservation and maintenance?







Q7 The city should prioritize the Pavement Management Program in its budget planning process.


















